A rapidly increasing number of states have been developing Quality Rating Systems (QRS) to help policymakers and consumers assess the quality levels of Head Start, child care, state-funded pre-k programs, and early education and care programs within a state.

QRS provides information to state policymakers that can be used to increase the quality of early childhood and care programs and to target needed professional development.
